

The Hong Kong Jockey Club Music and Dance Scholarship Application Guideline (2026/27 Cohort)

1. About The Hong Kong Jockey Club Scholarships

Established in 1998, The Hong Kong Jockey Club Scholarships are dedicated to nurturing compassionate and socially-minded leaders for the betterment of Hong Kong. Over the past 27 years, the Scholarships have supported more than 1,200 outstanding young people in pursuing their academic and professional aspirations.

The Scholarships support outstanding students across diverse backgrounds: local, Chinese Mainland, and international undergraduate students in Hong Kong; students with special educational needs; vocational education students; and exceptional young artists pursuing professional studies in music and dance at world-renowned institutions outside Hong Kong. In addition, the Scholarships enable exceptional Hong Kong graduate students to pursue Master's and Doctoral degrees at leading universities worldwide, such as Harvard University, the Massachusetts Institute of Technology, the University of Cambridge and the University of Oxford.

Through the Institute of Philanthropy, Graduate Scholarships at Peking University and Tsinghua University are offered to Hong Kong students pursuing Master's or Doctoral degrees in Chinese Mainland.

2. Objectives and Scope

The Hong Kong Jockey Club Music and Dance Scholarship ("Music and Dance Scholarship") enables young talents of outstanding calibre in music and dance to pursue professional performing arts studies at world-renowned institutions outside Hong Kong.

Through this initiative, awardees are given the opportunity to fully dedicate themselves to their artistic development and pursuits. The Scholarship provides three programmes, tailored to support students at different stages of their artistic journey:

The intended programme must be a **full-time performing arts programme** at a world-renowned institution outside Hong Kong.

The Scholarship supports the following items within the covered study period: (a) full tuition fees, (b) subsistence allowance and maintenance fees, (c) one set of return flight ticket to the place of study, and (d) other learning subsidies. Please visit section 14 for more information.

3. Eligibility

[Note 1] Applicants under 18 must obtain a guarantee from a parent or legal guardian.

[Note 2] Applicants must meet all entry requirements of their intended programme and institution. At the time of confirming the scholarship award, they must have secured unconditional admission to one of the intended programmes and institutions listed in their application. Failure to do so may result in withdrawal of the award.

4. Selection Criteria

The selection for the Scholarship will comprehensively evaluate the following information about the applicant:

- Track record of artistic excellence;
- Track record of performance achievements;
- Demonstrated commitment to community service; and
- Leadership qualities and character.

6. Application Procedures

The application for the Music and Dance Scholarship is open from **5 December 2025 to 27 February 2026, 6:00 PM**. Late application / further amendment WILL NOT be accepted.

Before starting an application, applicants should inform their school referees and referees to obtain their consent and email addresses.

School Referee

For Junior and Undergraduate Programme applicants, a school referee should be the school principal or a teacher from the applicant's current school.

For Postgraduate Programme applicants, a school referee should be teaching professional familiar with the applicant's academic background.

Referee

For all applicants, a referee should be a professional in the corresponding music/dance field e.g. a current/retired faculty member of a tertiary institution, a current/retired player in an established music/dance professional body or organisation, etc.). The referee must not be the same person who completed the School Recommendation Form.

After collecting their email addresses, applicants should start and activate the application process via the online application portal ([link](#)) on the [scholarship's official website](#). After activating the application process via the application portal, separate emails containing the portal login information will be sent to you, your school referee and your referee respectively. For the format of the Login ID and more details, please refer to table 1.

Only complete applications submitted before the deadline via the application portal will be considered. To avoid network issues near the deadline, the applicant should allow sufficient time to gather the relevant online forms and submit the online applications before the deadline. After the release of public exam results and institution admission results, shortlisted applicants will be notified by email and are required to submit the following items to the application portal within FIVE working days:

- The copy of public exam result / grade report / certificate
- Admission offer letter
- Offer acceptance proof or deposit fee payslip

Please be reminded that, for certain supporting documents, the applicants may require assistance from their corresponding schools. Hence, applicants are recommended to prepare these supporting documents in advance.

Applicants must ensure that the information submitted is true, accurate, and complete. Otherwise, the Club reserves the absolute right to disqualify the applications. In addition, applications completed in a non-specified format, submitted through non-designated means, or fail to submit required documents will not be considered.

9. Audition/Interview Assessment

Shortlisted applicants will be invited to attend an in-person audition/interview, tentatively scheduled for Late April - May 2026, at a designated timeslot assigned by the Scholarships Secretariat.

Shortlisted applicants must attend the audition/interview in person and at the timeslot assigned by the Scholarships Secretariat. Failing which, the Scholarships Secretariat reserves the absolute right to disqualify the applicant. **Request for re-scheduling the interview will not be entertained.**

Shortlisted applicants should bring their audition materials (e.g. own instruments / dance costumes) to the audition / interview.

Depending on the applicant's discipline of study, the following will be assessed during the audition/interview by a panel of the Club's Voting Members and music/dance experts respectively:

10. Submission of Public Examination Results and Institution Admission Results

For **Undergraduate Programme** applicants: Upon the release of public examination results and institution admission results, as well as receipt of the reminder email from the Scholarships Secretariat, the applicants should upload their public examination results and institution admission results to the application portal **within FIVE working days**. If the Scholarships Secretariat does not receive the requested document of proof within five working days after the release of public examination results and institution admission result, the Scholarships Secretariat reserves the absolute right not to process the application further.

Tentatively, results of Hong Kong Diploma of Secondary Education Examination (HKDSE) will be announced on 15 July 2026 (Wednesday). Hence, applicants should provide their HKDSE examination results to the Scholarships Secretariat by 20 July 2026 (Monday).

For applicants who do not apply for institutions via HKDSE, they are also required to provide their public examination results within five working days following result release and their institution admission results (if available by that time) to the Scholarships Secretariat by 10 August 2026.

Selection Results

11. Results

Successful applicants will be informed of the result of their applications in writing by the end of June - July 2026. If applicants do not receive any notifications from the Scholarships Secretariat by the end of Aug 2026, they may deem that their applications are unsuccessful.

Successful applicants will be given a conditional offer, and they are required to submit **proof of successful admission results** (e.g. offer letter) of their first or second intended programme **within FIVE days of receiving the offer.**

It is the applicants' responsibility to secure admission to the intended programme. Applicants must observe the entry requirements of the intended programme and/or institution and ensure that they meet such requirements. At the time when the scholarships are offered to the selected applicants, they should have secured unconditional admission to at least one of their first two intended programmes; failing which the scholarship award may be withdrawn.

12. Letter of Undertaking

Successful applicants are required to sign a Letter of Undertaking on the terms of the Music and Dance Scholarship.

13. Conditions for the Award of the Music and Dance Scholarship

The award of the Music and Dance Scholarship is conditional upon the selected applicants fulfilling **ALL** the following conditions:

- (i) All academic proof is received and verified by the Scholarships Secretariat within the requested timeframe;
- (ii) All music- or dance-related employment, performance and award proof are verified by the Scholarships Secretariat;
- (iii) The applicant enrolls in either one of their intended programmes at the Institution in the upcoming academic year; and
- (iv) The admission result of intended programme is verified by the Scholarships Secretariat

14. Coverage of the Music and Dance Scholarship

The Scholarship supports students in pursuing professional training in music or dance at world-renowned institutions outside Hong Kong (duration as specified in each programme):

- (a) **Tuition fees:** Pecuniary payment covering the tuition fee for the academic year will be disbursed directly to your Institution or by reimbursement during the covered study period
- (b) **Subsistence allowance and maintenance fees:** Accommodation and health insurance, as well as fixed amount for living and academic expenses
- (c) **One set of round-trip flight tickets:** Start of study to the destination and end of study back to Hong Kong
- (d) **Other learning subsidies:** Cost of participation in international competitions, summer festivals

The actual scholarship entitlement depends on the Scholarship you are awarded, your Institution and your selected programme. The scholarship value in a particular academic year is also subject to adjustment to reflect changes in tuition fees, academic allowance and living expenses.

Depending on the nature of the covered items, the scholarship will be disbursed either through the institutions or by the Scholarships Secretariat.

For JC Scholars who do not complete their study programme within the normal length of study due to health or other special conditions, the Club may provide flexibility and accommodation on scholarship payment schedule based on student requests and recommendations from the respective Institution. Such arrangements are subject to the Scholarships Secretariat's review and approval on a case-by-case basis.

15. Concurrent Awards

Upon your acceptance of the Scholarship, you should not accept or receive any other academic scholarships, awards, or funding that subsidise your tuition fees, subsistence expenses, maintenance fees, flight tickets or other learning subsidies covered by the Scholarship during the covered study period.

However, you may continue to receive other honours, recognitions and awards, such as those that recognise your specific contributions or achievements, and, in the case of students with special educational needs, provide supporting equipment, alongside the Scholarship.

16. Termination of the Music and Dance Scholarship

The Music and Dance Scholarship covers the JC Scholar's covered study period of the selected programme set out in the scholarship undertaking letter.

Further, the Club may revoke the award of the Music and Dance Scholarship to a JC Scholar:

- If the Scholar discontinues his/her enrolment in the same Institution; or
- If the Scholar fails to fulfil his/her Institution's condition for continuation of study; or
- If the Institution does not recommend for the continuity of his/her award of the scholarship; or
- Due to other special considerations as decided by the Club.

Students with their Music and Dance Scholarship revoked shall no longer be referred to as a JC Scholar and will no longer be entitled to use the title JC Scholar or participate in the events and activities of The Jockey Club Scholars Alumni Association.

17. The Jockey Club Scholar Experience

As a JC Scholar, the student will become a member of a network of past and current JC Scholars and enjoy various privileges, such as opportunities to participate in learning, networking and community service programmes. All JC Scholars are required to attend the scholarship award presentation ceremony of their cohort and an induction programme and are expected to actively support alumni activities to the best of their abilities. JC Scholars are also automatically enrolled

as a member of The Hong Kong Jockey Club Scholars Alumni Association, a self-running, Club-supported organisation that was established to mobilise JC Scholars to serve the community.

18. Interpretation

The Club reserves the right of final decision in case of any dispute, controversy, difference or claim arising out of or relating to this Application Guideline and changes to its terms and conditions whenever deemed appropriate without any prior notice.
